Golf Course Rules

USGA rules will govern all play unless modified by local rules

Players must register with Pro Shop before playing

Players may be grouped together to form foursomes. No more than 4 players per group,

Juniors must have a driver's license in order to drive a cart.

Electric carts observe and obey all markings on the course. Carts will come to a stop when entering areas marked as no carts

Keep push carts and bags off tee boxes

Repair ball marks, replace divots and rake all bunkers

Pace of play target time located on each course's scorecard

Riverside encourages the Tee It Forward Program

Smoking is prohibited per city ordinance

No cutoff shirts, tank tops or cutoff jeans allowed

Coolers are not permitted at any time

Patrons are forbidden from bringing their own alcohol to the course. Alcohol cannot be consumed in the parking lots at any time

All alcohol consumed on the golf course or in the clubhouse must be purchased from the restaurant

24-hour cancellation policy. Any member who does not cancel their tee time within the cancellation policy, may have their 10 day advance booking privileges removed. If members continue to disobey the policy, additional privileges may be removed.

Golfers are expected to be courteous and follow all general etiquette

Players are responsible for any injury to people or damage to property caused by their actions

Harassing or verbally abusing others golfers, the golf staff and restaurant staff will not be tolerated

All golfers are required to check in at least fifteen minutes prior to assigned tee time. Any group not on the tee and ready to play on time may lose its tee time. The Pro Shop and Starter have the authority to maintain order on the course.

Failure to follow the course rules may result in removal from the golf course without refund

WAIVER RELEASE OF ALL LIABILITY**

I hereby request that I be permitted to perform or engage in certain entertainment activity at a City of Portland facility, namely that I be permitted to play golf and otherwise be present at Riverside Golf Course in Portland, Maine (hereinafter the "Activity"). I understand that participating in this Activity involves risk of injury to all parts of my body. I understand that there are numerous risks including, but in no way limited to, uneven terrain, fall hazards, environmental conditions, the configuration of the facilities, slipping and falling, motorized carts, and other risks associated with this Activity, which independently or in connection with my actions or the actions of others, may cause severe or even fatal injuries to me or others.

I further understand that COVID-19 has been declared a worldwide pandemic by the World Health Organization and that COVID-19 is extremely contagious. Although the City of Portland has put in place preventative measures to reduce the spread of COVID-19, I understand and acknowledge that the City of Portland cannot guarantee that I, my children, or any other person, will not become infected with COVID-19 while engaging in the Activity. I understand that the risk of becoming exposed to or infected by COVID-19 during the Activity may result from my acts or omissions or those of others, including but not limited to City employees, volunteers, contractors, and other Activity participants.

IN CONSIDERATION of being permitted to engage in the Activity, and for other good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge:

1. I acknowledge, agree and represent that the Activity that I am going to voluntarily engage in may involve the risk of serious bodily injury, illness, and/or death and/or property damage. I agree that I alone am responsible for my safety while participating in this Activity.
2. I acknowledge, agree and represent that the City of Portland, their agents, officers, and employees (collectively, the "City") accept no responsibility and will not be liable for any injury, illness, harm, or damage to my person or my property occurring during, or arising out of, or in connection with, the Activity.
3. To the fullest extent permitted by law, I do hereby agree to assume all risk of injury, harm, or damage to me and/or my property, and/or to the property of others in my possession (including but not limited to all risks of injury, harm or damage caused by the negligence of the City arising during or in connection with the Activity. I do hereby release and agree to defend, indemnify, and hold the City harmless from any and all liability, actions, damages, and claims of any kind and nature whatsoever, (including but not limited to liability, actions, damages, and claims caused by or arising from the negligence of the City for injury, harm or damage to me and/or my property, and/or to the property of others in my possession, and/or to other persons or property in any way caused by my actions or inactions, (including but not limited to disability or death) that may arise out of, or occur during or in connection with said Activity. I do hereby promise not to sue the City with respect to any such claims or liabilities. This waiver and release is intended to be as broad as the law allows.

I have read the entire release, understand it, and am signing this agreement freely.

And further, I hereby give my permission for emergency medical treatment in case I am unable to consent and the contact above cannot be reached.

The City of Portland, ME is not responsible for security of lockers/bag room or items stored in them. Those applying for resident rates must provide two forms of identification with name and address. Riverside is a non-smoking facility.
